## **RANGLETT'S RECREATION GROUND PHASE 3 – APPOINTMENT OF CONTRACTOR TO DELIVER SKATE PARK**

#### PURPOSE OF REPORT

1. To obtain Executive Cabinet approval to appoint Canvas Spaces Ltd to deliver Ranglett's Recreation Ground Skate Park (Phase 3) under a design and build contract. The procurement approach and evaluation criteria for the appointment of a design and build contractor for Ranglett's Recreation Ground Phase 3 were approved by Executive Member Decision in October 2014.

#### **RECOMMENDATION(S)**

2. To approve the appointment of Canvas Spaces Ltd. to deliver Ranglett's Recreation Ground (Phase 3) Skate Park.

#### **EXECUTIVE SUMMARY OF REPORT**

- 3. Executive Member approval was granted in October 2014 for the procurement methodology, evaluation criteria and inclusion in the evaluation process of a 'project team', comprising local skateboarders and BMX riders, for the appointment of a contractor to deliver Ranglett's Recreation Ground Phase 3 Skate Park. The budget for delivery of this contract is £100,000.
- 4. Four tenders were returned and were evaluated by Chorley Council Parks and Open Spaces Evaluation Team and the Project Evaluation Team of local stakeholders in accordance with the evaluation criteria set out in the Invitation to Tender Document. The overall scores for the returned tenders varied from 68% to 83.6%. As follows:

Canvas Spaces Ltd 83.6% Freestyle Skateparks Ltd 82.1% Wheelscape 71.4% Bendcrete 68%

5. Following the tender evaluation process the top two designs (Canvas and Freestyle) were shortlisted. Due to the close scoring of these two highest scoring tenderers, the designers were invited to present their designs to the 'Design Team' of local stakeholders on Saturday 31<sup>st</sup> January at Eaves Green Community Centre and a vote was then taken. Provision for this vote in the event of very close scoring tenders was made within the Invitation to Tender Document. All three members of the design team panel voted in favour of the Canvas Spaces Ltd. design. The Canvas Spaces Ltd. design is appended to this report.

The Canvas Spaces Ltd. design was the highest scoring tender return and was also voted the favourite by all the stakeholders following the designer presentations.


13. The proposed contract award is in accordance with the procedure agreed by Executive Member Decision in October 2014.


