POLLING PLACE REVIEW 2019 - RESULTS OF CONSULTATION

PURPOSE OF REPORT

1. To report the findings of the Polling Place Review 2019 and propose alternative options for polling station for members consideration.

RECOMMENDATION(S)

2. That there be no changes to existing polling district, polling place and polling station arrangements for the current wards. The rationale for this recommendation is too allow voters to attend their usual polling station should an anticipated parliamentary election be announced. Implementing changes at this stage, would result in a significant number of voters having to attend different polling stations than they would normally, which would cause confusion amongst residents. In some cases, voters may decide not to vote on this occasion citing the change of polling station as the reason.
3. That the issues raised during the consultation are considered by officers at greater length alongside the new warding arrangements that have been implemented following an electoral review of Chorley Council. Proposed changes to be presented at a future council meeting for approval prior to implementation at the local authority election scheduled for 7 May 2020.

BACKGROUND

5. Local authorities have a legal requirement to undertake a review of their polling districts, polling places and polling stations every 5 years. Although the duration of the actual review is not stipulated, the review must be completed by January 2020.

6. A condition of the review is that it must be conducted on current ward boundaries. Therefore, the recommendations and issues highlighted in this report are only concerned with the current warding arrangements. However, paragraph 18 of this report, does consider the implications relating to the new ward boundaries which will come into force at the next local borough election on 7 May 2020.

REVIEW PROCESS

7. A preliminary review of polling stations was conducted with elected members earlier this year, when views were sought on the suitability of existing polling stations.
8. In total three members responded to this review, two of which expressed their satisfaction on the current polling stations within their ward. The third member raised issues with their ward's current polling station and suggested potential premises that could be used as an alternative polling place.
9. The full review of Polling Districts, Polling Places and Polling Stations began on 26 July 2019 with the launch of a public consultation lasting six weeks. Interested residents and groups in the parliamentary constituencies of Chorley and South Ribble were invited to complete an online survey, email in suggestions, or send their written response through the post to the Elections Team by Friday, 6 September 2019.

RAISING AWARENESS

10. To increase public awareness of the review and consultation, a dedicated webpage was developed on the council's website providing more information and a link to the online survey. In addition to this, a public notice about the review has been displayed on the noticeboards of the -
 - town hall
 - market
 - council run community centres
11. Social media has been utilised to promote the review and consultation, with a series of posts and tweets being released throughout the consultation period encouraging responses. In addition, articles have also been published in the council ezines *intheknow* and *intheboro*.
12. The authority has also consulted extensively on the review seeking the views of interested individuals or groups as well as other elected representatives including:
 - elected representatives for Chorley
 - MP's for the parliamentary constituency of Chorley and South Ribble
 - political parties in both Chorley and South Ribble Parliamentary Constituencies
 - Acting Returning Officer for South Ribble Borough Council
 - Lancashire County Councillors
 - North West MEP's
 - Parish and town councils (which included the request to display the notice of review on their noticeboards)
 - Equality Forum membership
 - Chorley VCFS Network (which included the request that they circulate the information to their members)
 - Age Concern
13. Although the timing of the review, which has taken place over the summer holiday period was not ideal, it was unavoidable due to the unscheduled European Parliamentary election,

the Ecclestone and Mawdesley by election, and to fall in line with the council meeting's timetable.

RESULTS OF THE CONSULTATION

14. In total 170 responses were submitted; 156 of those responded to the online survey. The response to the consultation can be viewed in appendix a.
15. The main issues highlighted during the consultation included –
 - closure of schools for polling stations;
 - lack of (suitable) parking;
 - housing estates that have been split into different polling districts, resulting in residents from the same estate having to attend different polling stations. This is mainly due to the borough wards, county divisions and parish/parish wards boundaries not aligning;
 - the suitability of existing polling stations accommodating new/growing housing developments (eg Buckshaw Village and Euxton);
 - lack of polling stations in some wards, particularly rural areas.
16. Through the consultation, it has become clear, that the closure of schools to allow the premise to be used as a polling station has become deeply unpopular amongst respondents. This could, in part, be due to the number of unscheduled elections and referenda which had taken place during the last three years. This has resulted in some schools having to close at relatively short notice which impacts on the school's curriculum. It has also resulted in parents having to make childcare arrangements, at a cost to the parent in some cases. A few respondents have also raised criticism about the fairness in schools being closed whenever there is an election, while parents are being fined for their child's unauthorised absences.
17. Nevertheless, using public funded buildings, such as schools are important to the polling premise stock, as it provides a certain amount of reassurance that these premises will be available to the Returning Officer to use should an unscheduled election or referendum be announced. This is distinct from privately run premises, where there is no obligation towards the Returning Officer to make them available. This could result in a shortage of polling places with very little time to make alternative arrangements; and inform voters of any changes.

NEW WARD BOUNDARY IMPLICATIONS

18. Following the results of electoral review of Chorley Council which was undertaken by the Local Government Boundary Commission for England to rectify voter equality across the borough, a whole of council election will take place at the next scheduled local elections on 7 May 2020. Due to a reduction in the number of wards (from 20 to 14), each ward contains a greater number of electors. The suitability in size and location of polling stations need to be considered in greater detail.
19. Where possible, voters will attend the polling station nearest to them (this may be different to the one they are attending at present). However, it is inevitable that new polling stations will be introduced in some areas due to changes in polling districts.
20. A report will be presented to a future council meeting detailing proposed change for members approval prior to implementation for the 7 May 2020 local elections.

22. Due to the present political climate, there is an expectation that a parliamentary election will be announced imminently. Changing voters polling stations for this election may prove unpopular for a variety of reasons, including voters –

- presenting themselves at the wrong polling station
- not knowing where their new polling station is

Ultimately, changes to polling stations may result in some voters choosing not to vote, and citing the premise change as the reason, for which council may be subject to criticism. Although the council would endeavour to publicise any changes to polling stations, there would not be enough time to mount a full publicity campaign.

23. By not implementing any changes to polling stations until the scheduled local election on 7 May 2020, those groups and individuals who took part in the consultation may consider that their views have been ignored, and that the consultation was a 'tick box' exercise to satisfy the council's legislation requirements.

25. The proposal on deferring any changes to polling places until the implementation of the boundary review is reasonable given the possibility of a general election taking place in the near future. It would be better to avoid any risk of confusion in the minds of members of the public caused by changing their usual polling station, particularly as there is a risk of further changes when the changes to ward boundaries are implemented following the review.

Thanks for the opportunity to comment.

Please can you submit my comments as below:

Buckshaw Village

Whilst the room itself in the RMG Community Centre is itself fine, I think the accessibility of this location is poor. There is little car parking available until all the nearby services - schools, doctor and dentists have closed. The Hub car park now has a barrier with access restricted to customers only. Furthermore, the footpath connections are poor, often with cars parked on them which severely restricts access.

I would ask the Council to give serious consideration to using the new Community Centre located nearby on Lancaster Way. This building has its own car park with plenty of overflow parking available just yards away. Footpath provision is much better too.

Euxton

I would ask the Council to consider using the PC Community Centre and minimise the impact on the schools. The Community Centre is well connected and has ample parking and is in a central location.

Astley Village

I wouldn't suggest any alterations to the current arrangements.

Sirs,

For the purpose of your review I would like you to consider the polling station provision within the parish of Anderton.

Currently we have only one polling station location (Anderton Primary School) which serves for both parish elections and Adlington & Anderton ward borough elections. This school is located on the northern boundary of our area adjacent to Adlington.

With the increase in residential population towards the southern extremity of the parish (Bolton Road, Horwich boundary; Owsten Court etc.) we consider these areas are not well served and it requires the undertaking of a significant journey for the purpose of elections.

Unfortunately we are not aware of any public buildings that could be used as a polling station in the immediate vicinity, so it would require a mobile station to be deployed. Equally we do not have any voting pattern statistics to justify the need, however we do feel this issue is worthy of consideration in respect of future needs.

Re: Polling Station Review Consultation

Dear Cathryn,

I am writing to express my views and those of the governing board of Euxton Primrose Hill Primary School in relation to the use of our school as a polling Station. As you will already be aware, the school has been used as a polling station for a great number of years. For the vast majority of elections, the school has managed to remain open to pupils as we have been able to utilise mobile accommodation previously on site and, more recently, spare classrooms following the expansion of the school's buildings. As you will understand, as headteacher, I always have the pupils' best interests at heart and do not like to close for polling, particularly as the date falls so close to scheduled bank holidays and half terms and would mean another lost day of education for pupils in close proximity to statutory assessment dates.

As a school we only have two years left until we will be at full capacity with over 420 pupils on role. This will mean that we will no longer have spare classrooms to utilise and would give me very little option other than to schedule an INSET day for the school to be used as a polling station. As mentioned previously, this would have a negative impact on pupils' learning so close to key assessment dates but such an INSET day is also of little use for staff training at this time of year when the majority of school development work has been implemented earlier in the academic year. Furthermore, next year we are likely to be having further building work undertaken to develop provision for year Six pupils, meaning that the site could not be used by visitors without closing the school to pupils.

Over recent years with the increase in pupil numbers, traffic in the vicinity of school has become a major issue with roads being blocked and pupil safety compromised. This further adds to the point that I would be forced to close school in the event that the school continues to be used as a polling station, negatively impacting on pupils' education.

Having willingly worked closely with the council over many years, I believe that this is now the right time to consider alternative options for a venue for a polling station enabling our growing school to function for its main aim of education. I strongly request that the points highlighted within this letter are considered and an alternative venue found as soon as possible.

Hi Phil, Cathryn.

The three Euxton labour Cllr, Gillian Sharples, Tommy Gray and myself have discussed the polling station for the new Euxton ward and these are our finding.

The old Euxton North.

* Primrose hill School is ok for the next two years then it will be at full capacity and we are trying to get away from school. Option NO.

* Changing rooms at Greenside playing field. Very small and not fit for purpose
Option NO

* Euxton Library. You would have to get permission from LCC. Parking around the area and easy walking access
Option THE BEST ONE

Electorates on the other side of the railway on Euxton Lane

* Scout hut at the end of Milestone Meadow. Bad to get to and could cause a problem with traffic driving though the estate. Option NOT A GOOD ONE

* Runshaw College. Lots of room and good parking, this would take pressure off the Library. Would need permission from the college Option YES.

The old Euxton South

* Balshaw Lane School. Room very small but as approximately 900 electorate will be moving into the Croston, Mawdesley & Euxton South ward it might not be as bad. But as with Primrose Hill we are trying to get away from Schools if possible
Option MIGHT BE THE ONLY ONE

* Cricket club. Would people walk there. Lots of parking but only one room.
Option POOR

Chorley Council notes the recent proposals published by Our Health, Our Care regarding the future of Accident & Emergency services in the Chorley, South Ribble and Preston Hospitals. The report indicates that any A&E provision at Chorley would not be viable. The Council strongly opposes any proposal for a single site Accident & Emergency based at Preston Hospital. The Council believes such a proposal would have a detrimental impact on the quality of local health care for the local population and that Chorley needs a 24 hour Accident & Emergency department. The Council believes the only potential viable proposal for a single site Accident & Emergency would be through a new super hospital located at a central point within the Chorley, South Ribble and Preston area. However, this option has not been included in the list of options produced by Our Health Our Care. Chorley Council asks that all options are included for consideration. In addition the Council urges the Hospital Trust to address the reasons why an A&E at Chorley Hospital is not deemed viable rather than simply propose to close the unit and move all A&E services to Preston.
