#### **PURPOSE OF REPORT**

### **RECOMMENDATION(S)**

2. Parish Councillor Anthony Wilson be appointed as a Parish Council representative on the Standards Committee.

#### **EXECUTIVE SUMMARY OF REPORT**

- 3. The local assessment of complaints against Councillors requires the potential for three subcommittees to be available. Each sub-committee must consist of no less than three members of the standards committee, including an Independent member and a Parish Council representative if the matter under consideration relates to parish issues.
