

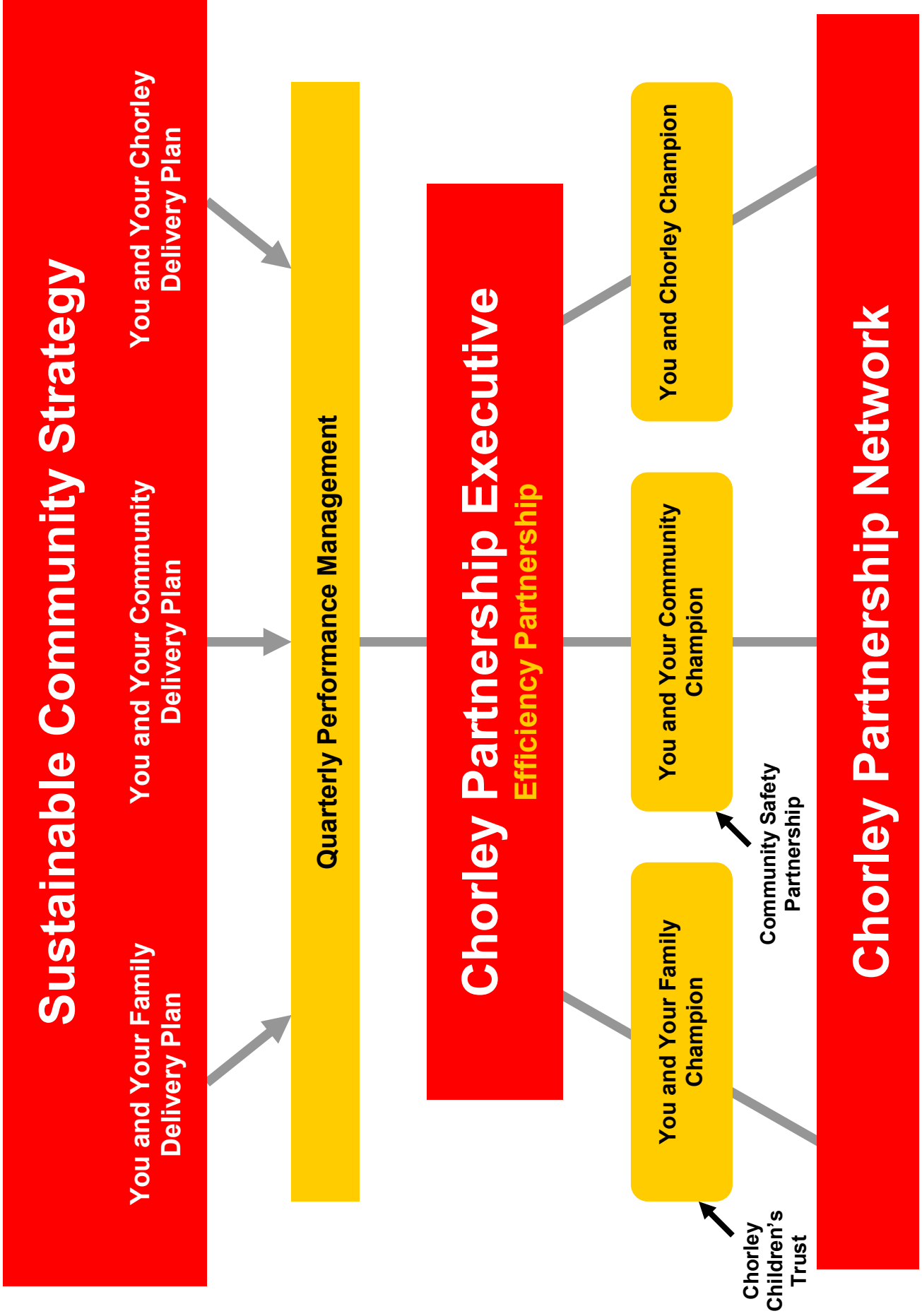

<p>Rationale</p>	<p>Following the proposed Government reforms to the NHS with regards the abolition of PCTs and creation of GP Consortia, a footprint of Chorley and South Ribble has been identified.</p> <p>It was felt that to ensure Scrutiny are fully equipped to maximise the opportunities of future NHS reforms around GP Consortia to improve the health and well-being of their communities that further research, engagement and a review of the accountability of the proposals would be helpful.</p> <p>To help with the review and ensure learning was captured a bid was made to the North West Employers' Member Innovation fund.</p> <p>This bid was successful and the following aspects proposed:</p> <ul style="list-style-type: none"> ▶ Networking and information sharing on Government proposals and the implications for councils, GPs and the community to create a greater understanding of the opportunities and break-down any barriers ▶ Workshop between South Ribble Borough Council, Chorley Council and Lancashire County Council Members, NHS Central Lancashire and GPs in the locality to gain an understanding of how they can work more closely together, engage with communities, support each other and ensure democratic accountability. ▶ Preparation of feedback report to share learning on the project. ▶ Dissemination of learning through events, website existing local government and health
