# 06/00099/FUL - CHURCH OF THE BLESSED VIRGIN MARY, TOWNGATE, **ECCLESTON**

A further letter has been received from the Church warden (who has written previously) asking that certain issues be brought to the attention of the newly formed Development Control Committee.

The proposed development is on the site of an existing building of no architectural merit and in matching materials to the historic building. The Church is attempting to comply with their statutory legal obligation to provide toilet facilities for the disabled along with two small meeting rooms and a kitchen. This will enable them to provide a better service for the Church community and also the wider parish community.

The development is not only for 'church people'.
