# ENFORCEMENT VISITS FOR PERIOD FROM 01 SEPTEMBER 2006 TO 22 SEPTEMBER 2006

6. Visits were made to the following premises:

Licensing Manager Howard Bee attended and took part in a multi-agency operation, which took place on 15 September 2006. In conjunction with three police officers the following premises were visited

Sir Henry Tate - The police reminded the DPS that a condition of his licence requires him to become a member of pub watch. The DPS stated he would join and be present at the next meeting.

Licence summary is displayed.

Tut n Shive, Applejax, White Hart, Swann with two necks - all displaying licence summary.

The Queens - licence summary displayed.

Front doors wedged open with loud music, DPS advised on conditions on his licence i.e. keeping doors and windows closed.

The Police walked around all the above premises looking for banned persons and known troublemakers.

Routine checks have also been made to check if licensed premises are displaying the licence summary as required by the Act.

It appears that further visits and education is needed to advise licensees of their responsibility to display licence summaries and steps are being taken in this respect.

Visits were made as follows: -	
Londis, Park Road, Chorley	summary displayed
Market Tavern, Chorley	summary displayed
Fifteen, Fazakerley Street	summary displayed but asked for it to be moved to a
	prominent position.

Spar, Market Street, Chorley...no summary displayed. A representative from the firm's head office contacted the Licensing Section and was unaware of the requirement.

American Chicken & Pizza, Market Street, Chorley. No summary displayed, licensee out of country, staff advised.

Prince of Wales, New Market Street, Chorley. No summary displayed, no licence holder on premises, staff stated that they were unaware of any requirements. Details of this have been passed to the Police.
