medication as prescribed by his General Practitioner, however the Committee acknowledged that GPA had presented medical evidence today that he was fit to drive. Committee also took note of the fact that GPA indicated he was now administering medication in accordance with his doctors instructions.

The Committee resolved to lift the suspension of his drivers license and allow GPA to continue to drive on the condition that he provide evidence from his doctor indicating that GPA meets Group 2 medical standards in respect of his blood pressure and diabetes every month to the licensing section. Furthermore the situation be reviewed after 6 months and GPA required to undertake a full medical prior to renewal of his license in 2008.
