Path Diversion Order to divert lengths of Public Footpaths 44, 45, 46 and 48 at Coppull on the ground that the Council considers that the existing hard surfaced footpaths provide a superior walking route.

2 That the County Council's Countryside Officer be advised to investigate the alleged closure of the existing lengths of public footpath without permission.
