4. <u>Lancashire Constabulary Consultation - the Front Counter and</u> <u>Estates Organisational Review</u>

Lancashire Constabulary and the Police Authority are consulting on recommendations to close some front counters within Police Stations across the county. Inspector Alison Barff will be attending the meeting to outline the recommendations and to pass any feedback from the Forum into the consultation process.

What it the purpose of this item?

A review has been undertaken based on the footfall at these counters, and found that 81% of the total footfall of visitors across the county is catered for by just 17 of the front counters. The remaining 21 are dealing with only 19% of the overall footfall and are therefore recommended for closure. A consultation on these recommendations is launched on 1 July and will run for 12 weeks, after which final decisions will be taken.

11.EF.10 WELCOME AND INTRODUCTIONS

11.EF.12 MINUTES

That the minutes of the meeting held on 18 January 2011 be confirmed as a correct record, apart from a question omitted from the minutes, by Marel Urry relating transport difficulties in Hoghton and Brindle. Sarah James responded to the question at the close of the meeting.

11.EF.13 CONCESSIONARY TRAVEL

Tony Moreton gave an overview on Concessionary Travel, reporting that for the vast majority of residents there would be no change in their travel requirements. This included the NOW cards which allows residents, who are eligible to received one, free travel on local bus services between 9.30am and 11.00pm, with a small charge for those travelling before 9.30am.

Members of the Forum were advised that Lancashire County Council and District Council's had pooled money together to fund community transport schemes such as Dial-a-Ride and the Community Car Hire Scheme for a further three months. Funding for these schemes had previously been withdrawn due the shortfall in Government budget allowance.

During the three month period a consultation exercise would take place, while officers would consider all options available to them to find alternative ways of keeping the services running.

Members of the Forum were encouraged to make their views known by taking part in the consultation exercise.

Members of the Forum thanked Lancashire County Council for their continued effort in supporting the community transport scheme for a further three months, but expressed their concern of how the cancellation of the schemes would impact on the residents who used them. Tony Moreton explained that unlike other bus services which are statutory, community transport schemes had always been discretionary.

Members of the Forum asked for a number of issues to be considered within the consultation including:

- consider those areas not covered by a bus service at the moment
- older people visiting hospitals as patients or hospital visitors
- the feelings of isolation that would be felt by those people who were reliant on these services if they were cancelled

At the conclusion of the presentation the Chair asked for questions from the Forum.

There was a discussion on the benefit of the new microchip NOW Smart Cards and the possible development opportunity's that the technology could bring.

In response to a question raised, the Forum was advised that special needs school transport could be provided following an assessment. However, this would not apply for those students studying at college.

The Chair thanked Tony Moreton for attending the meeting and reminded Members of the Forum to take part in the consultation on Community Transport by contacting Lancashire County Council with their concerns.

11.EF.14 CHORLEY COUNCIL'S APPROACH TO EQUALITY - THE NEW EQUALITY SCHEME

Sarah James gave an overview of the review of the Council's Equality Scheme.

Members of the Forum were informed that the existing scheme had been updated to take account of new legislation in the Equality Act 2010, and as a result there had been changes to the Council's general duties and specific duties with regards to equality. Taking in to account the new legislation, the Council has identified nine equality strands:

- Age
- Disability
- Gender Reassignment
- Pregnancy and Maternity
- Race
- Religion and Belief
- Rurality
- Sex
- Sexual Orientation

It was recognised that these groups may need additional consideration in service delivery or policy development.

All of the strands identified, except rurality, are protected by law through the Equality Act as people who have protected characteristics. In addition Chorley Council had chosen to recognise rurality as an equality strand because of the issues that people living in rural areas can face when accessing services.

The new scheme was approved at the Executive Cabinet on 31 March 2011.

Members of the Forum were advised of the processes that were in place which embedded equality and diversity in every aspect of the Council's roles and responsibilities including its responsibility as an employer.

At the next meeting of the Forum the equality strands will be changed to take in to account the nine new equality stands.

11.EF.15 TOWN CENTRE ACCESSIBILITY ACTION PLAN UPDATE

- 6a Sarah James updated the Forum on the progress of work identified in the Town Centre Accessibility Action Plan.
 - Smaller works identified in the Action Plan had either been completed or had been scheduled to be completed in the near future.

- There was still work outstanding on the Flat Iron car park. This work however, is subject to a much larger development and the works identified would be incorporated within the development.
- Officers of the Council were still communicating with market traders and shopkeepers of their responsibilities in relation to street furniture and 'A' boards through Town Centre Workshop meetings and individually.

Negotiations were still on going with Lancashire County Council on the devolution of their enforcement powers to Chorley. However, no date for the transfer of responsibility had been proposed.

• A process has been implemented to ensure that the gates which are situated at strategic points of the town centre, to turn the town centre in to a predestrianised zone, are closed at the correct time.

In response to members of the Forum's concerns that there was still a potential danger from cyclists riding their bikes while the Town Centre was pedestrianised, Chris Sinnott advised that any other form of barrier had to out weigh the cost and potential success.

6b Eileen Bee gave an update on the Buckshaw Village Surgery which was currently progressing through the planning process. It was anticipated the timescale for the handover would be April 2012.

11.EF.16 OPEN FORUM TO DISCUSS ANY ISSUES FOR EACH EQUALITY STRAND

(a) Age

- Joyce Morris expressed her concern that Lancashire County Council had decided to withdraw funding to the Chorley and South Ribble CVS.
- Councillor Rosemary Russell alerted members of the Forum about malicious telephone calls being directed at elderly residents in which they were being told that Chorley Council would evict them from their home because of their age. If

Eileen Bee advised that she shared Joyce Morris' concern • that Lancashire County Council had decided to withdraw funding to Chorley and South Ribble CVS (Minute 11.EF.16a).

Chris Sinnott confirmed that, at their annual review, Lancashire County Council had decided not to fund a number of CVS districts in the first round of funding allocations. However, it was still possible for the CVS to reapply for funding under the second funding round.

Members of the Forum asked that comments raised at this meeting be fed back to Lancashire County Council.

Equality Forum 11 April 2011 Q&A

Community Transport Review / Issues;

- 1. Geraldine Moore's question raised access issues for hospital visiting/health appointments. Disproportionate effect that possible charges to community transport on older people who may also face losing services due to the rise in the level of eligibility for care with less of moderate level support increased isolation. Older People need to be involved in the consultation.
- 2. Marel Urry was concerned that in several rural areas – Withnell, Withnell Fold, Hoghton, Brindle etc there was no public transport (bus or train) to give access to Chorley. She was aware that there was currently a review being undertaken by LCC on Concessionary Travel. For some of the more vulnerable groups living in the rural areas, Dial-a-Ride and similar schemes form our sole affordable means of access to the social and other facilities (hospital, supermarkets etc) enjoyed by others in the Chorley Borough area. Ms Urry was aware LCC have supported rural and concessionary transport as a discretionary rather than a statutory provision, and thanked them for their previous effort and support. Having a blue badge and her NOW card had really improved her quality of life. It made a big difference to a persons self confidence being able to leave the house and go to Chorley. Ms Urry was sure she was not alone in feeling less isolated and still a part of the local community. Social access and interaction was important for all members of our Ms Urry asked that LCC bear that in mind when community. discussing and reaching their decisions on concessionary and rural transport to enable true equality of opportunity and access.
- 3. From Concessionary Travel discussion; Members of the Forum had asked for a number of issues to be considered within the consultation including:
 - consider those areas not covered by a bus service at the moment
 - older people visiting hospitals as patients or hospital visitors
 - the feelings of isolation that would be felt by those people who were reliant on these services if they were cancelled.

4. Douglas Bailey's was concerned with the decision of LCC not to replace bus stops and time tables.

Lancashire County Council Response to all the issues raised; Tony Moreton, Lancashire County Council's Assistant Director for Sustainable Transport, was in attendance at the meeting and will consider the issues raised and comments made as part of the wider consultation process

CVS Funding

- 1. Could it be reported back to LCC that is unfair the funding for certain districts of CVS has been cut.
- 2. Joyce Morris expressed her concern that Lancashire County Council had decided to withdraw funding to the Chorley and South Ribble CVS.
- 3. Eileen Bee advised that she shared Joyce Morris' concern that Lancashire County Council had decided to withdraw funding to Chorley and South Ribble CVS

Lancashire County Council Response;

Lancashire County Council's overall grants budget for 2011/2012 is the same as last financial year, it has not been reduced. All seven CVS's in Lancashire applied for funding from the County Council but it was felt by the assessment panel and subsequently by the cross party VCFS Cabinet Working Group that only two of the applications met the revised criteria.

In general, the key areas where CVS's failed to meet the criteria were (i) around demonstrating a viable business plan for moving away from reliance on core funding/management costs and (ii) demonstrating that they were targeting activity and outcomes around the priority area of helping to prepare VCFS groups to be able to deliver public services in the future

There is a second funding round for the unspent Central Gateway Grant monies and CVS's are free to re-apply.

Town Centre Accessibility

1. Comments made around the ongoing need for enforcement of pavement cafes and A Boards to ensure that the pavements remain clear of obstructions has been passed on to Alan Capstick, the Public Realm Manager for Chorley at Lancashire County Council.
