## GENERAL PROCEDURE POINTS FOR HEARINGS DETERMINING MATTERS UNDER THE GAMBLING ACT 2005

#### **INTRODUCTION**

The Licensing Act 2003 Sub-Committee will conduct hearings in relation to determination of matters under the Gambling Act 2005 in accordance with the following general principles:

- All parties have a right to a fair hearing.
- Decision-making will be conducted in an open, transparent and accountable way.
- Each application will be determined on its own merits and the decision will be based upon:
  - the merits of the application
  - the promotion of the three licensing objectives in the Gambling Act 2005
  - the Council's Statement of Licensing Policy
  - the Guidance issued by the Gambling Commission under Section 25 of the Gambling Act 2005
- the Licensing Authority will only permit licensing decisions to be taken by Sub-Committee consisting of three members. In the event of one member being unable to attend, the Licensing authority will use its best endeavours to substitute another member, taken from the membership of the Licensing Act 2003 Sub-Committee reserve list.
- the Sub-Committee may disallow cross-examination in exceptional circumstances; this decision will be taken on a case by case basis with a presumption to allow. However, parties are advised that the Sub-Committee wishes to discourage hostile cross examination.
- late representations and evidence will usually only be considered with the agreement of all parties present.
- decisions will generally be taken regardless of whether the applicant/other party is present unless the Sub-Committee consider it necessary in the public interest to adjourn the hearing to a specified date. All notices and representations from absent parties will be considered.
- the Sub-Committee will generally allow parties a maximum of 30 minutes per party to make all relevant Statements. However, the Sub-Committee recognises that in certain circumstances this may be insufficient due to the complexity of the issues involved. In this situation the Sub-Committee will consider representations from those parties involved in the hearing as to the length required to make all relevant statements. The Licensing Authority respectfully requests that all parties keep points pertinent and the discussion moving in the interests of cost and efficiency.

the Sub-Committee recognises that Regulation 8 of The Gambling Act 2005 (Proceedings of Licensing Committees and Sub-committees) (Premises Licences and Provisional Statements) (England and Wales) Regulations 2007 requires that all hearings should take place in public unless the committee is satisfied that it is necessary in all the circumstances of the case to hold the hearing in private, having regard to (i) any unfairness to a party that is likely to result from a hearing in public, and (ii) the need to protect as far as possible the commercial or other legitimate interests of a party. The Licensing Authority has adopted the existing criteria in Schedule 12A of the Local Government Act 1972 for excluding the press and public. Generally, the public and the applicant will be excluded when the Sub-Committee is determining a decision. Once a decision has been made all parties will be readmitted and the Chair will announce the decision and give reasons.

- all parties will be notified of the decision in accordance with any periods set down by the Gambling Act 2005 or regulations made there under or where none are prescribed within 5 working days.
- the Sub-Committee has the right to exclude any parties behaving in a disruptive manner at the hearing at its own discretion.

## THE GAMBLING ACT 2005; APPLICATION FOR A GAMING **MACHINE PERMIT FOR MORE THAN 2 GAMING MACHINES.**

#### **PURPOSE OF REPORT**

To bring to the attention of Members an application received from Poppleston Allen 1. Solicitors in respect of an application for a Gaming Machine Permit for more than 2 gaming machines for a premise licensed under the Licensing Act 2003 known as The Highfield Restaurant Southport Rd Leyland.

#### **RECOMMENDATION(S)**

2. Members are recommended to consider the contents of the report and any representations made by the representative of Mitchells and Butler Leisure Retail Ltd and determine whether or not to grant the application.

#### EXECUTIVE SUMMARY OF REPORT

3. Poppleston Allen Solicitors made application under Schedule 13, of the Gambling Act 2005 for a Gaming Machine Permit for 2 or more gaming machines on behalf of Mitchells and Butler Leisure Retail Ltd being the premises licence holder for The Highfield Restaurant. The application is attached as Appendix 1. The Council's Statement of Gambling Policy states that each application will be determined on a case by case basis, the Council's scheme of delegation does not authorise officers to determine the application where the application is for more than 2 gaming machines.

#### BACKGROUND

5. The Council has received an application made under Schedule 13 of the Gambling Act 2005 for more than 2 gaming machines for the public house The Highfield Restaurant. The premises benefits from a Premises licence issued under Section 17 of the Licensing Act

2003 authorising the sale of alcohol, this authorisation is a pre-requisite to enable the above application. The Premises Licence PLA0138 and Plan are attached as Appendix 2.

- 6. Where a premises wishes to have more than two machines, then it needs to apply for a Gaming Machine permit and the Authority will consider that application based upon the licensing objectives, the Guidance, and such matters as they think relevant. Members should be satisfied that the granting of the said permit will not undermine the licensing objectives and that the applicant is aware of the positive steps required to promote the licensing objectives. This Authority considers that such applications will be decided on a case-by-case basis, but generally there will be regard for the need to protect children and vulnerable persons from harm or being exploited by gambling. The Licensing Authority will expect the applicant to satisfy it that there will be sufficient measures to ensure that under 18 year olds do not have access to the adult only gaming machines. Such measures may include the adult machines being in sight of the bar, or in the sight of staff who will monitor that the machines are not being used by those under 18. Additionally, Notices and signage may also be of assistance. With regard to the protection of vulnerable persons, applicants may wish to consider the provision of information leaflets/helpline numbers for organisations such as Gam Care. It is important that staff are able to see if the machines are being played by any adults with a gambling problem.
- 7. Officers attended the premises on 8 October 2015 to assess the suitability of the premises to accommodate additional gaming machines in line with the application received. It was noted that two existing Category C gaming machines on the premises are positioned in an area of the premises reserved for over 18s only together with a skills machine. Other areas of the premises are designed as family friendly and the premises promotes its self as such offering a childrens ball play area, extensive restaurant facilities, three crane grab machines and a number of novalty machines dispensing toys. There was no evidence that the premises promoted any advice or guidance to its staff or public in relation to the use or control of the machines. The premises presently benefits from a Gaming Machine Permit for 2 category C machines and 1 category D machine, the application recieved seeks authority to introduce one additional category D machine.
- 8. The current Designated Premises Supervisor was not available at the time of the officer visit to the premises.
- 9. Members will be aware that the following machines were being made available to the public at the time of the licensing visit 8<sup>th</sup> October 2015;

2 x Cat C gaming machines (located within the over 18s area) 1 x skills machine (located within the over 18s area) (genuine skill machines are outside the allotted quota of machines in the Gambling Act 2005) 2 x grab machines (within the main restaurant area) 5 x toy dispensing machines (within the main restaurant area) 1 x grab machines (within the soft ball area)

- 10. Members will be aware of the recent notification received by the Gambling Commission attached as Appendix 3, giving clarification to what category grab machines might fall into given the type of consruction, operation and specification. Given the complexity of the different types of grab machines available and the technical specifications offered by the various manufactures officers are not able to determine what category the existing grab machines fall into, there was no obvious marking on the machines as required to advise the public. On 9 October 2015 Officer sought clarification of this issue via the applicants solicitor.
- 11. Officers received a set of operating instructions for one Prize Zone Crane, this indicates that the machine to which it relates would fall into a Cat D machine, attached as a

**Appendix 4.** Officers have requested clarification as to which grab machine or machines the manual relates, however at the time of writing this report had not received a reply.

- 12. Officers will offer a verbal update as to the status of the further two grab machines at the hearing should we receive such confirmation.
- 13. In determining this matter Members shall have consideration for the following provisions;

Chorley Council's Statement of Gambling Policy. Attached as **Appendix 5.** 

Members are reminded of the Gambling Act 2005 licensing objectives which are;

- (a) Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime,
- (b) Ensuring that gambling is conducted in a fair and open way, and
- (c) Protecting children and other vulnerable persons from being harmed or exploited by gambling.
- The Gambling Commissions published code of practice provides the requirements that must be complied with by the Gambling Machine Permit Holder. The document is attached at Appendix 6. The guidance is applicable to all licensed premises in relation to any number of gaming machines that are provided.
- 15. Member's attention is drawn to the committee's discretion in determining this matter which is prescribed within Schedule 13 Section 283 of the Gambling Act 2005 which states they may:
  - a) Grant the application,
  - b) Refuse the application,
  - c) Grant it in respect of;
    - 1) A smaller number of machines than that specified in the application,
    - 2) A different category of machines from that specified in the application, or
    - 3) Both.
  - d) Members may not attach conditions to a permit.

The applicant in respect of this application has been invited to attend the hearing and make representation.

#### COMMENTS OF THE MONITORING OFFICER

1. Under Schedule 13 of the Gambling Act 2005 members must have regard to the licensing objectives contained in the Gambling Act 2005, national guidance issued by the Gambling Commission the latest edition of which was published in September 2015 and such other

matters as they think are relevant. It would be reasonable for members to have regard to the Council's own statement of gambling policy.

Other relevant considerations would be the location of the proposed machines so that staff could clearly see minors or problem gamblers attempting to play the machines and intervene. Also the location is a relevant consideration for fire safety.

Provisions of the Human Rights Act 1998 are relevant to the application, including but not limited to Article 1, Protocol 1 (peaceful enjoyment of possessions) and Article 6 (right to a fair hearing). In the event that the application is granted in whole or in part then under section 282 of the Gambling Act 2005 the location and operation of the machines must be in accordance with any relevant Code of Practice issued by the Gambling Commission.

The applicant has a right of appeal to the magistrates' court within 21 days of receiving notice of the decision to (i) reject the application or (ii) grant an application for a smaller number of machines than that specified in the application or a different category of machines from that specified in the application (or both)

- The premises must be licensed under the Licensing Act 2003 to sell alcohol for consumption on the premises, without the 2. requirement that alcohol is served only with food and there must be a bar for serving alcohol to customers on the premises.

- A 'Premises Licence holder' is a person holding a Premises Licence under the Licensing Act 2003. 4
- There is no statutory limit to the number of machines which may be applied for although the licensing authority has some 5. discretion in this regard. It should also be noted that the licensing authority can cancel the permit or vary the number of machines should the premises be mainly used for making gaming machines available for use on the premises (Schedule 13 paragraph 16 Gambling Act 2005). You may therefore wish to contact the licensing authority to ask whether there is a local policy as regards applications and whether application for certain numbers of machines are decided via a hearing of local councilors.
- The permit's duration is indefinite as it is linked to the Licensing Act 2003 Premises Licence. There is a first annual fee 6. payable by ..... and an annual fee payable after that before each anniversary of the date of issue of the permit. Failure to pay the annual fee may result in the cancellation of the permit. The annual fee is £50.00. There are no annual fees payable for 2 machines or less.
- Sections 282 and 283, as well as SI 2007 / ..... of the Gambling Act 2005 provide for two types of gaming 7. machines which can be located in alcohol licensed premises. These are:
  - a category C gaming machine has a maximum cash stake £1.00 and prize £70
  - A category D gaming machines can have different maximum stake and prizes depending on the type of machine:-
    - Where the prize is money the maximum stake 10p and cash prize £5.
    - Where the prize is not money the maximum stake is 30p and the maximum prize value is £8.
    - For mixed money and non money prize gaming machines the maximum stake is 10p and maximum prize value £8 of which £5 can be cash.
    - · For crane grab machines only, which have non money prizes, maximum stake £1 and the maximum prize value £50.
    - For coin pushers or penny fall only the maximum cash stake is 10p and maximum prize value is £15 which can include up to £8 maximum of cash.
- All alcohol licensed premises which provide gaming machines for use on the premises must comply with 8. any relevant Code of Practice Issued by the Gambling Commission under Section 24 of the Gambling Act 2005. The Gaming Machine Code of Practice for Alcohol licensed premises permits and permissions is available via the Gambling Commission's website at: http://www.gamblingcommission.gov.uk/ Should you be unclear as to the provisions of the code of practice please contact the Gambling Commission or your local Council licensing service.
- This licensing authority must notify the applicant of its grant / refusal of the application for a permit as soon as is 9. reasonable practicable after that decision to grant / refuse has been made.



(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner

DISPENSING ALCOHOL

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

#### FREE TAP WATER

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

#### AGE VERIFICATION

(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.





# New Yellow Box Control System Breakdown of Adjustments.

- 1 **Motor speed:** The speed of the gantry motors can be increased or decreased by adjusting the dip switches as desired '0' = slowest, '9' = fastest, this alters the speed of the gantry when the player is moving the gantry around & the return speed of the gantry after it has grabbed the toy.
- 2 Free Credit Button: This allows the operator to activate a game without incrementing the meters.
- 3 Credit Cancel Button: This allows the operator to clear all remaining credits.
- 4 Attract Music Switch: This allows the operator to select if they want the attract music on or off. (the attract music plays every 10 minutes).
- 5 Prize Every Time/ Std Play Switch: This allows the operator to select the type of game played.

If switched to Prize Every Time, the credit will remain until the prize sensor detects a prize out & then the credit will be deducted ( we have set in the software a maximum of 25 attempts to win the prize per credit, if you require a no limit type you can contact us & we will generate you a different software set).

the unit is switched to Std play, the game will finish when the gantry gets back to the home position (usually if set to Std play a percentage payout system will be required, if you require this system it can be purchased from our spares department).

6 **Consolation Prize Switch:** this feature can only be used if a consolation prize hopper is fitted, the benefit of this feature is that if the unit is set to Std Play, if the player does not win the main prize from the machine, the operator can set the unit to give a small prize I.E. a bouncy ball or capsule. There are 3 settings for this feature,

<u>After</u>  $\equiv$  The consolation prize will be paid after the game (unless the main prize is won then the consolation prize will be cancelled).

<u>Before =</u> The consolation prize will be given before the game starts.

<u>None</u>  $\equiv$  The consolation prize is switched off.

- 7 Volume control: adjust this to suit your location.
- 8 **Credit meter:** this counter counts the amount of games played, if you multiply this by the Price of Play you will achieve the total cash takings.
- 9 **Prizes meter:** This counter displays the amount of prizes won from the machine.
- 10 Percentage control dummy grey plug: this is the port where the Supergrab Handset will plug into the main CPU, to activate the percentage control simply, switch the machine to std play, un plug the grey dummy plug & plug the lead from the supergrab handset into the yellow box. this handset is not fitted as standard. the next page in this manual gives the operator a breakdown of how to set up the handset for full percentage control. if you require any further information on this product please contact our spares department on 01507 490003.
- 11 Price of Play: There is a bank of DIL switches located on the coin mech with a sticker for various price of play options. (See last Page)
- 12 Fuses: There are 3 fuses on this machine, the first (mains protection 5A quick blow) is located on the mains inlet on the back of the machine, the second & the third fuses (both 5A Quick Blow) are inside the main Yellow CPU, these cover the grab cicuit & motor drive circuit. Their is also an on / off switch on the Yellow PSU.

#### **Classification of crane machines**

We have recently been working with the trade body BACTA and machine suppliers in order to reinforce the message that certain types of machine currently operated as skills with prizes (SWPs), with a maximum stake of £1 and £50 non-monetary prize, should be correctly labelled as category D non-complex crane grab machines.

In some cases premises licences or permits may be needed in order to site these machines and some unlicensed operators will have to apply for an operator's licence.

Whilst the majority of machines of this nature are operated as cranes within adult gaming and family entertainment centres under the category D stake and prize limits, there has been a recent trend whereby they are being offered to the public, particularly children, purporting to be a skill machine as opposed to a gaming machine without the necessary permissions to do so. This occurs in pubs, shopping centres, motorway service stations and other similar venues.

Furthermore, as stated in the October 2014 LA bulletin, machines which are capable of being used as a gaming machine, whether or not they are currently operating as a gaming machine, are classified as a gaming machine. For example, a machine fitted with a compensator, which allows it to be converted from a skill machine to a gaming machine, is classified under the Gambling Act 2005 (s 235) as a gaming machine.

Machines utilising a mechanical arm, or similar device to select a prize and which employ a compensator unit to determine the percentage pay-out of the machine, need to be clearly marked as a gaming machine (skill and chance combined). In addition they may only be operated in premises where the necessary permissions are in force.

There are no statutory limits in place regulating stakes and prizes for SWPs. However the Commission and HMRC are of the view that it is unlikely that a maximum prize greater than £50 would be commercially viable in a genuine skill game. In fact, a voluntary limit had previously been agreed between machine manufacturers and trade bodies, limiting the price of one game to £1 and the maximum prize to £50 (wholesale value). See the guick guide on SWPs for more info.

#### **Timetable**

We have set out a timetable by which those wishing to make such machines available to the public should obtain the necessary permissions and where required adjust the stake and/or prizes available accordingly.

- Where a new permit or a variation to an existing permit is required from the local • licensing authority as a result of this clarification, then the process must be underway by 31 August 2015 and the permit or premises licence must be granted and in place by 31 December 2015.
- Similarly, an operator, that is currently supplying or maintaining these types of • machine on the assumption they were SWPs, must apply for an operator's licence by

31 August 2015. (Check the licence register of those who hold or have applied for an operators' licence).

• Where there is no possibility that the permission will be granted the machine(s) should be removed from site immediately.

#### Communication

- BACTA has written to its members, as well as produced various articles for Coinslot and other industry publications.
- Machine suppliers Namco and Sega have also written to those operators who have purchased crane machines from them.
- We have advised LAs of the change through the July 2015 LA bulletin.
- LAs may wish to seek written reassurance from those entities siting machines that they comply with the regulatory requirements.





#### Machine technical standards

Where a machine determines whether a player has an opportunity to win a prize partly by chance (using a compensator or control system to control the payout) but also by a player using a degree of skill to ultimately win the prize, the machine would be considered a game of chance and skill combined.

This is captured by section 6(2)(a) of the Gambling Act 2005 as a game of chance and will therefore be defined as a gaming machine.

The definition of category D non-complex crane machines in our *Technical Standards* will be amended to exactly replicate the definition of crane in *The Categories of Gaming Machine (Amendment) Regulations 2009 (No 1502):* 

A crane grab machine is a reference to a non-money prize machine in respect of which-

- (i) every prize which can be won as a result of using the machine consists of an individual physical object (such as a stuffed toy), and
- (ii) whether or not a person using the machine wins a prize is determined by the person's success or failure in manipulating a device forming part of the machine so as to separate, and keep separate, one or more physical objects from a group of such objects.

In general, the only requirement needed to make existing crane grab machines compliant with the regulation and our technical standards would be to include a display notice on the machine stating that it is a category D gaming machine with the proviso that the stake/prize does not exceed the statutory limits of £1/£50 respectively and that prizes are totally non-monetary.

Should the industry attempt to exploit the situation in a manner deemed undesirable or outside the spirit of that intended then we may review our position in this matter.

# Gaming Machine Permits Code of Practice

- Club Gaming Permits and Club Machine Permits
- Alcohol Licensed Premises Permits and Permissions and automatic entitlements

June 2007

## Introduction

- i. This is the Gambling Commission's Code of Practice issued under section 24 Gambling Act 2005 (the Act) relating to provision of facilities for gambling in accordance with club gaming, club machine and licensed premises gaming machine permits. This includes:
  - registrations under Parts II and III Gaming Act 1968 which, under transitional provisions, are treated as club gaming and club machine permits respectively; and
  - alcohol licensed premises gaming machine permits (formerly s34 1968 Act permits).
- ii. The Code will come into force on 1 September 2007.
- iii. Those items marked in bold and shaded are the provisions which are a condition of the permit and must be complied with.

# Section A: Location and operation of machines

All permit holders

Compliance with these provisions is a condition of your permit, and failure to do so could result in revocation of the permit.<sup>1</sup>

1 All gaming machines situated on the premises must be located in a place within the premises so that their use can be supervised, either by staff whose duties include such supervision (including bar or floor staff) or by other means.

Permit holders must have in place arrangements for such supervision.

2 All gaming machines situated on the premises shall be located in a place that requires a customer who wishes to use any ATM made available on the premises to cease gambling at the gaming machine in order to do so. 'ATM' means a machine located on the premises, which enables a person using it to obtain cash by use of a credit or debit card.

# Section B: Access to gambling by children and young persons

All permit holders

This section sets out the best practice which the Gambling Commission considers should be implemented by permit-holders, compliance with this provision is not a condition of your permit.

- 3 Permit holders should put into effect procedures intended to prevent underage gambling. This should include procedures for:
  - checking the age of apparently underage customers; and
  - refusing access to anyone who appears to be underage, and who tries to use category B or C gaming machines and cannot produce an acceptable form of identification.
- Permit holders should take all reasonable steps to ensure that all relevant employees 4 understand their responsibilities for preventing underage gambling.
- 5 Permit holders should only accept identification which:
  - contains a photograph from which the individual can be identified;
  - is valid: and
  - is legible and has no visible signs of tampering or reproduction. •

(The Commission considers acceptable forms of identification to include any identification carrying the PASS logo (eg Citizencard, Validate and the Government's own Connexions card); driving licence (including a provisional licence) with photocard; and passport).

6 Procedures should be in place for dealing with cases where a child or young person repeatedly attempts to gamble on category B or C machines, including oral warnings, reporting the offence to the Gambling Commission and the police, and making available information on problem gambling.

## Section C: Self exclusion

This section sets out the best practice which the Gambling Commission considers should be implemented by permit-holders, compliance with this provision is not a condition of your permit.

Club gaming permit and club machine permit holders only

- 7 Permit holders should put in place procedures for self-exclusion and take all reasonable steps to refuse service or to otherwise prevent an individual who has entered a selfexclusion agreement from participating in gambling.
- 8 Permit holders should implement procedures designed to ensure that an individual who has self-excluded cannot gain access to gambling; this includes:
  - a register of those excluded with appropriate records (name, address, other • details, and any membership or account details that may be held by the operator);
  - photo identification (where available and in particular where enforcement of the • system may depend on photographic ID), and a signature;
  - staff training to ensure that relevant staff are able to enforce the systems; and
  - the removal of those self-excluded persons found in the gambling area or

attempting to gamble from the premises.

- 9 Self-exclusion procedures should require individuals to take positive action in order to self-exclude. This can be a signature on a self-exclusion form.
- **10** Before an individual self-excludes, permit holders should provide or make available sufficient information about what the consequences of self-exclusion are. Customers should be given the opportunity to discuss self-exclusion in private, where possible.
- 11 Permit holders should take all reasonable steps to ensure that:
  - the self-exclusion period is a minimum of six months and give customers the option of extending this to a total of at least five years;
  - a customer who has decided to enter a self-exclusion agreement is given the opportunity to so do immediately without any cooling off period. However, if the customer wishes to consider the self exclusion further (for example to discuss with problem gambling groups) the customer may return at a later date to enter into self exclusion;
  - at the end of the period chosen by the customer (and at least six months later), maintain the self-exclusion in place, unless the customer takes positive action in order to gamble again. No marketing material may be sent to the individual unless that has taken positive action in order to gamble again, and has agreed to accept such material; and
  - where a customer chooses not to renew, and makes a positive request to begin gambling again, give the customer 1 day to cool off before being allowed access to the gambling facilities.
- 12 Please note that the Commission does not require the permit-holder to carry out an assessment or make any judgement of whether the individual should have access to gambling. The requirement to take positive action in person or over the phone is purely to:
  - a) check that the customer has considered the decision to access gambling again and allow them to consider the implications; and
  - b) implement the 1 day cooling-off period and explain why this has been put in place.
