	<p>To consider the exclusion of the press and public for the following items of business on the ground that it involves the likely disclosure of exempt information as defined in Paragraphs 1 and 3 of Part 1 of Schedule 12A to the Local Government Act 1972.</p> <p>By Virtue of Paragraph 3: Information relating to the financial or business affairs of any particular person (including the authority holding that information) Condition:</p> <p>Information is not exempt if it is required to be registered under-</p> <ul style="list-style-type: none"> <li>The Companies Act 1985</li> <li>The Friendly Societies Act 1974</li> <li>The Friendly Societies Act 1992</li> <li>The Industrial and Provident Societies Acts 1965 to 1978</li> <li>The Building Societies Act 1986 (recorded in the public file of any building society, within the meaning of the Act)</li> <li>The Charities Act 1993</li> </ul> <p>Information is exempt to the extent that, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.</p> <p>Information is not exempt if it relates to proposed development for which the local planning authority may grant itself planning permission pursuant to Regulation 3 of the Town &amp; Country Planning General Regulations 1992(a).</p>
