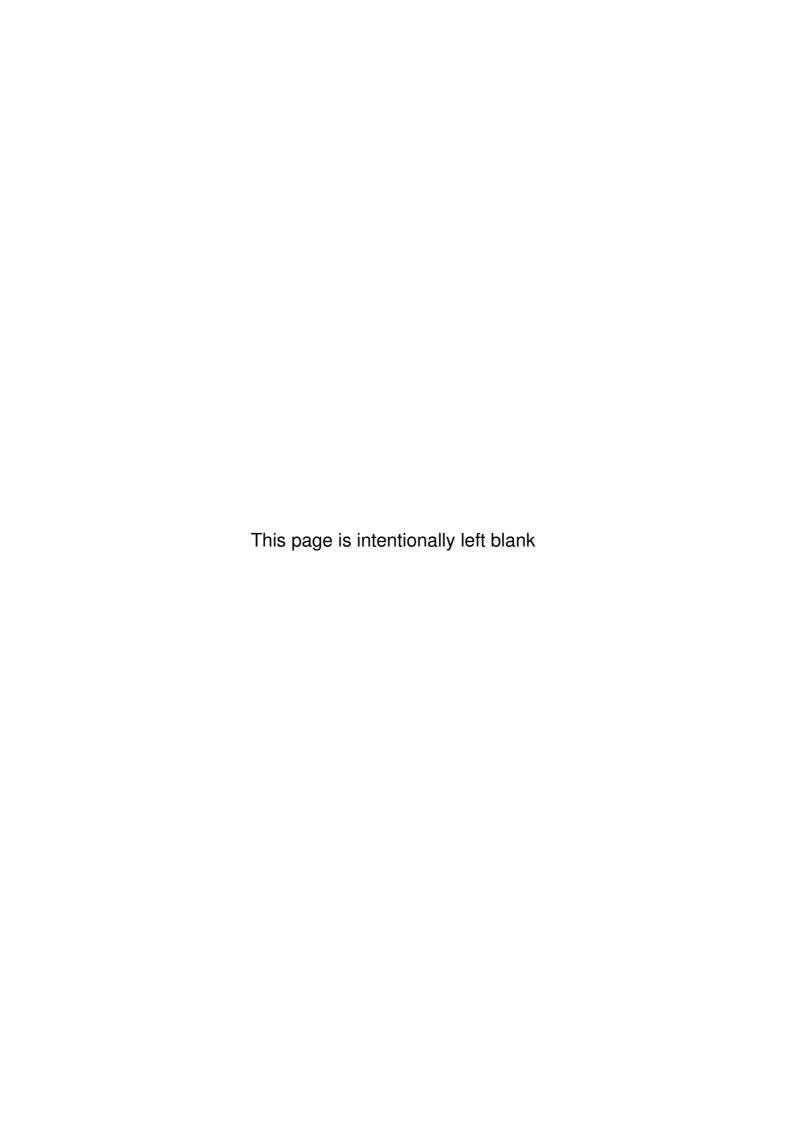

06.LS.59 PRIVATE HIRE DRIVER - COMPLAINT OF INAPPROPRIATE BEHAVIOUR -MR HBK (DOB 10.01.57)

Further to Minute 06.LS.51, 20 September 2006, the Committee received a report of the Director of Customer, Democratic and Legal Services bringing Members attention to a complaint that had been received against a Private Hire driver regarding an allegation of inappropriate behaviour.

The Committee was requested to consider the allegations and determine whether he was a fit and proper person to hold a private hire driver's licence.

The Private Hire Driver attended the meeting to put forward his explanation, and the Committee carefully considered the representations he made.

RESOLVED - That the Committee viewed the complaint very seriously, however, it was agreed that the Private Hire Driver be allowed to continue to drive in Chorley and a letter be sent informing him that his conduct must be exemplary and should there be any further concern or complaints he be brought back to a meeting of the Committee.

06.LS.60 PRIVATE HIRE OPERATOR ALLOWING VEHICLES TO BE USED IN A DANGEROUS CONDITION

Further to 06.LS.52, 20 September 2006, the Committee received a report of the Director of Customer, Democratic and Legal Services bringing to the attention of Members that a private hire vehicle had been presented for a taxi test in a dangerous condition.

A Vehicle Supervision Notice had been served on the operator of the vehicle and attended the meeting to explain how the licensed vehicle was allowed to be used in such a dangerous condition and to explain what, if any measure he had put in place to ensure that all licensed vehicles operated under his operator's licence were adequately maintained.

RESOLVED - 1) That the Committee considered that the licensed private hire operator was not a fit and proper person to hold a licence and agreed that the licence be suspended until the whole private hire fleet have been subjected to a vehicle test to be carried out during the next week by an accredited MOT testing station.

- 2) That a system of daily defect sheets be implemented for each vehicle of the private hire fleet and signed by each driver with detected faults to be rectified immediately.
- 3) That regular checks be made by the Council's Licensing Enforcement Officer to ensure that the daily defect sheet process is being complied with.
- 4) That the operator be asked to a future meeting to inform the Committee that the required tests have been carried out on the vehicles and the vehicle checking process is operating.
- 5) That a report be submitted to a future meeting on the outcome of an investigation to be carried out on the MOT testing of the people carrier in question and the suitability of the accredited testing station that had carried out the four month test on the vehicle and whether a satisfactory standard of service is being provided by the testing stations.

CONSIDERATION OF CHANGE OF CRITERIA – ADDITIONAL HACKNEY CARRIAGE VEHICLE LICENCES

PURPOSE OF REPORT

1. To ask Members to reconsider an agreed criteria to be applied to additional hackney carriage vehicle licences.

CORPORATE PRIORITIES

2. This report is not relevant to any of the key corporate priorities of the Council.

4. There is a risk that the criteria applied to the hackney carriage vehicle licences could be the subject of Judicial Review and that unsuccessful applicants could appeal to the Magistrates Court if their application is refused.

BACKGROUND

- 5. At a meeting of this Committee on 5 April 2006 a criteria was set for the issue of the seven additional hackney carriage licences identified by the recent survey as being required to meet the needs of disabled people in the Borough. (A copy of the Committee report dated 6 April 2006 is attached).
- 6. Best practice guidance issued by the Department for Transport on 23 October 2006 casts doubt on the already agreed criteria relating to the type and age of vehicle (copy of the relevant guidance is attached).
- 7. It is thought that the agreed criteria could result in a legal challenge. It is appropriate to reconsider the agreed criteria before any further action is taken regarding the issue of the seven additional hackney carriage plates.

- 8. It is suggested that the following criteria be considered to replace numbers 1, 2 and 3:
 - i) Every vehicle shall be either a purpose built hackney carriage or a vehicle adapted as a hackney carriage suitable for the carriage of disabled persons by a recognised conversion company. The vehicle must have undergone either Whole European Type Approval or Low Volume Type Approval.
 - ii) Vehicles must be new or have covered no more than 500 miles.
- 8. Changing the criteria will enable vehicle proprietors to have a choice of suitable vehicles whilst the Council will be able to maintain a high standard of vehicular accessible vehicles. By specifying that the vehicles must be new or less than 500 miles we can ensure that conversions have been carried out to the latest specifications.

VEHICLES

Specification Of Vehicle Types That May Be Licensed

- 18. The legislation gives local authorities a wide range of discretion over the types of vehicle that they can license as taxis or PHVs. Some authorities specify conditions that in practice can only be met by purpose-built vehicles but the majority license a range of vehicles.
- 19. Normally, the best practice is for local licensing authorities to adopt the principle of specifying as many different types of vehicle as possible. Indeed, local authorities might usefully set down a range of general criteria, leaving it open to the taxi and PHV trades to put forward vehicles of their own choice which can be shown to meet those criteria. In that way there can be flexibility for new vehicle types to be readily taken into account.
- 20. It is suggested that local licensing authorities should give very careful consideration to a policy which automatically rules out particular types of vehicle or prescribes only one type or a small number of types of vehicle. For example, the Department believes authorities should be particularly cautious about specifying only purpose-built taxis, with the strict constraint on supply that that implies. (There are at present only two designs of purpose-built taxi.) But of course the purpose-built vehicles are amongst those which a local authority could be expected to license. Similarly, it may be too restrictive to automatically rule out considering Multi-Purpose Vehicles, or to license them for fewer passengers than their seating capacity (provided of course that the capacity of the vehicle is not more than eight passengers).

CRITERIA TO BE APPLIED TO ADDITIONAL HACKNEY CARRIAGE VEHICLE LICENCES

PURPOSE OF REPORT

1. For Members to determine the criteria to be applied to the seven additional hackney carriage vehicle licences following the decision by this Committee at a special meeting on 29 April 2005 to grant an additional hackney carriage vehicle licence.

CORPORATE PRIORITIES

2. This report is not relevant to any of the key corporate priorities of the Council.

4. There is a risk that the criteria applied to the hackney carriage vehicle licences could be the subject of Judicial Review and that unsuccessful applicants could appeal to the Crown Court if their application is refused, which has costs implications inherent in defending any litigation.

BACKGROUND

- 5. Members will recall that at a Special Meeting on 29 April 2005 to the Committee resolved to issue a further 7 hackney carriage vehicle licences bringing the total number licensed by this Council to 37 following consideration of a report by independent consultants Halcrow Fox into the issue of demand for hackney carriage services in the Borough.
- 6. The Committee further resolved that these additional licences be issued subject to mandatory criteria relating to the vehicle and preferential criteria relating to the applicants/proprietors and that a further report regarding the criteria be submitted after consultation with the trade. A questionnaire regarding the proposed criteria was circulated to all members of the trade and interested parties, a copy of which is attached to this report at Appendix 1. A summary of the replies is attached at Appendix 2.



7. Members have previously adopted criteria in relation to hackney carriage vehicles and these are set out below.

Licensing Committee 22 November 2000 (Minute 00.L.76)

Further to minute 00.L.69, 11 October 2000, the Borough Solicitor submitted a report on the Hackney Carriage Plate No 6 that was held in abeyance and members were requested to set a criteria for which vehicle was best to serve the needs of disabled persons.

The Committee received representation from members of Chorley and South Ribble Disability Forum as to the type of vehicle(s) they considered would best meet their members needs.

Manufacturers of Metro Cab TTT and the TX1 and other purpose built wheelchair accessible hackney carriages, had been invited to demonstrate their latest products.

Resolved - That the following criteria be established for re-allocation of Hackney Carriage Plate No 6:

- (a) The following essential principles must be present in the vehicle:
 - i) Ramp
 - ii) Step
 - iii) Handrail
 - iv) Room to manoeuvre a wheelchair
 - v) Swivel seat
 - vi) Rear facing seat fastening
- (b) The desirability for suitable driver training.
- (c) Essential that there is a lack of taxi related convictions.
- (d) Essential to be resident of Chorley.

Licensing Committee 1 March 2001 (Minute 01.L.15)

The Committee received for approval an additional Licence Condition in respect of a vehicle constructed or adapted for the carriage of disabled persons.

Resolved - That the under mentioned clause be adopted as an additional licence condition for a hackney carriage licence:

'This licence is issued specifically in respect of a vehicle constructed or adapted for the carriage of disabled persons and once granted, the licensed vehicle and any replacement vehicle must:

- 1. In the opinion of the Council be suitable for the carriage of disabled persons.
- 2. At all times and comply with the specification guidelines set down by the Council for the time being in force; and/or
- 3. Comply with any regulations that may be made by the Secretary of State under the provisions of the Disability Act 1995.
- 8. Once the mandatory and preferential criteria have been determined applications for the additional licences will be invited. In the event that there are more applications than licences to be issued then the preferential criteria will be applied and if need be applications referred to this Committee for it to decide which applicants will be successful.
