All Staff will be provided with training in relation to the four licensing objectives and how we uphold and promote them. individual training records will be signed, dated and kept on site with refresher training to be given at 6 month intervals. The Training Record will contain information such as; The Licensing Objectives, fire safety instruction, Age verification, Logging incidents, Dealing with Drugs, anti-conflict etc..

CCTV recording is in operation on the premises and currently cover the front and rear enterances and the bar area. Recordings are kept for a minimum of 30 days and are available on request by the relevant authorities in support of the licensing objectives.

b) The prevention of crime and disorder

CCTV system in place in the premises with camera locations currently facing both front and rear entrances as well as the bar. Recording are recorded and kept on site for a period of 30 days. All members of Staff have been trained on how to access and download CCTV files to provide to relevant authorities if needed.

Incident logs are kept on site and completed to record any incidents in correlation with the Licensing Objectives.

Age refusal logs are kept on site and completed to record any details of age refusal sales.

c) Public safety

Premises complies with The Health & Safety at Work etc. Act 1974. Accident report log kept on site to record incidents involving public safety and emergency incidents.

Fire Risk Assessments to be carried out as part of opening routine and to be ticked off by member of staff. Fire extinguishers inspected and recorded monthly. Emergency fire evacuation plan noticed pinned up with nominated assembly point.

A regular inspection of the exterior of the premises to be done by staff and any litter that can be reasonably proposed to originate from the premises will be cleared and disposed of as appropriate.

d) The prevention of public nuisance

A contact telephone number for the premises shall be displayed that is visible from the exterior of the building in the event that contact needs to be made with the staff to deal with any issue that might arise from any licensable activity. Any person who is identified as causing antisocial behaviour, will be subject to a ban from the premises. A record of banned individuals shall be maintained on the premises and all staff made aware of the persons who are currently banned so that entry may be refused. This record shall be kept available for inspection on the premises. Staff instructed to check, in regular intervals, both interior and exterior for signs of anything that breaches the licensing objectives.

No Alcohol is permitted outside the premises with signs stating so.

Please leave quietly signs posted at front and rear exit to encourage customers leave in a calm and dignified manner. Taxi contact telephone numbers are available to assist customers on their journey home.

Local Taxi contact details posted up and available for the public near front and rear exits.  
Music volume lowered during last 30 minutes of trading.

e) The protection of children from harm

Children only allowed on the premises when supervised by Adult over the age of 18.

No Children to be admitted into the Premises after 21:00 unless already on the premises before 21:00.

A Challenge 25 scheme is in effect in compliance with the age verification condition: Customers who appear be under 25 years of age will be required to prove their age when purchasing alcohol. Suitable forms of identification will be a passport, 'Pass' card or other identification recognized by the licensing authority. Staff trained in Age VVerification.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
