# **MPV VEHICLE CONDITION – TRANSITION DATE**

### **PURPOSE OF REPORT**

1. To enable Members to review the implementation of a requirement that requires all multi passenger type vehicles (MPV's) to meet a transition date condition of 1 June 2011 which was approved by Members in October 2010.

#### **RECOMMENDATION(S)**

2. It is recommended that the transition date approved by Members is retained to ensure the Councils fleet of hackney carriage and private hire vehicles meet minimum requirements for passenger comfort when accessing and exiting MPV's.

### EXECUTIVE SUMMARY OF REPORT

- 3. Members received a report at the Licensing and Public Safety Committee on 20 October 2011 where the issue of multi passenger type vehicles (MPV) was considered in relation to proposed new conditions.
- 4. Members approved a set of conditions which ensured that the additional seating provided in MPVs were suitable for passenger comfort and in particular allowed ease of access and exit from the vehicle when the rear seats were in use.
- 5. In approving the conditions, Members also determined that a transition date should be set whereby all existing vehicles on fleet complied with the new condition. This date was set as 1 June 2011.
- 6. It is believed that this implementation date affects only two vehicles on fleet, beyond which those vehicles would have to removed from fleet or have their licence amended to reduce the number of passengers licensed to be carried from 6 passengers to 4 passengers.
- 7. Representations from the trade have been received which claim that this transition date is unfair and prejudices the respective proprietors ability to operate.
- 8. Members are invited to inspect the vehicle types in question and determine whether the transition date previously agreed should be retained.

## REASONS FOR RECOMMENDATION(S)

9. To ensure the Councils fleet of hackney and private hire vehicles are fit for purpose in so far as passenger comfort is concerned.
