PLANNING APPEALS LODGED

1. Appeal by Mr David Gregson against the delegated decision to refuse Full Planning Permission for proposed conservatory to rear elevation on existing raised patio area at Pike Lowe Farm, Pike Lowe Barn, Sandy Lane, Brinscall PR6 8SS (Planning Application: 12/00744/FUL Inspectorate Reference: APP/D2320/D/12/2184209). Planning Inspectorate letter received 17 October 2012.

PLANNING APPEALS DISMISSED

2. Appeal by Mrs S. Aspden against the delegated decision to refuse Outline Planning Permission for the erection of two detached houses on land opposite Greenways at land opposite Greenways, Parkside Drive South, Shaw Hill, Chorley PR6 7PH (Planning Application: 12/00022/OUT Inspectorate Reference APP/D2320/A/12/2177013). The appeal is dismissed. Planning Inspectorate decision received 18 October 2012.
