## **13.DC.65 MINUTES**

## **13.DC.66 DECLARATIONS OF ANY INTERESTS**

## **13.DC.67 PLANNING APPLICATIONS TO BE DETERMINED**

The Director of Partnerships, Planning and Policy submitted five applications for planning permission consideration.

In considering the applications, Members of the Development Control Committee took into account the agenda reports, the addendum and the verbal representations and submissions provided by officers and individuals.

- a) **Application:** 13/00600/FUL - Land 60m north to the rear of 34-42 and including 42 Chorley Lane, Charnock Richard **Proposal:** Demolition of 42 Chorley Lane and former nursery buildings and the erection of 8 dwellings, access road and associated development

**Speakers:** Objector – Andrea Currie, and the applicant's agent - Richard Percy.

**RESOLVED (unanimously) – That the decision be deferred to allow Members of the Development Control Committee time to visit the site of the proposals with an invitation extended to an officer from Lancashire County Highways also to be in attendance.**

- b) **Application:** 13/00560/FULMAJ - **Proposal:** Erection of 117 residential Former Discover Leisure site (Dave dwellings, car parking, access Barron Caravans), Chapel Lane, arrangements, public open space, Coppull, Chorley landscaping, a pumping station, associated works and infrastructure

**Speaker:** Applicant's agent – Daniel Jackson

**RESOLVED (unanimously) – That planning permission be approved subject to a Section 106 legal agreement, conditions detailed within the report in the agenda, additional conditions detailed in the addendum and officers given delegated powers to consider appropriate ecological conditions and negotiate with the applicant footpath improvement works.**

- c) **Application:** 13/00146/OUT - Land **Proposal:** Outline application (with all 20m north of 2 Clover Road/Jackson matters reserved) for the erection of a Road, Chorley detached bungalow

**RESOLVED (unanimously) – That planning permission be approved subject to a Section 106 legal agreement and the conditions detailed within the report in the agenda and subject to the deletion of condition 14 which duplicated condition 1 as detailed in the addendum.**

- d) **Application:** 13/00631/FUL - 26 **Proposal:** Erection of free standing Long Lane, Heath Charnock, adapted residential unit for disabled Chorley, PR6 9EN relative

**Speakers:** Ward Councillor – Councillor Kim Snape, and the applicant's agent - Chris Weetman.

**RESOLVED (unanimously) – That planning permission be approved subject to the conditions detailed within the addendum.**

- e) **Application:** 13/00608/FUL - Group **Proposal:** Amendments to planning 4N land 150 metres west of permission 10/00745/FULMAJ involving Sibbering's Farm, Dawson Lane, substitution of house types on plots 53 - Whittle-le-Woods 55 with associated works

**RESOLVED (unanimously) – That planning permission be approved subject to a supplemental Section 106 legal agreement and the conditions detailed within the report in the agenda.**
