APPLICATION FOR THE RENEWAL OF A PUBLIC ENTERTAINMENT LICENCE – THE SIRLOIN INN, STATION ROAD, HOGHTON, PRESTON

PURPOSE OF REPORT

1. To enable Members to consider an application for the renewal of a public entertainment licence at the above premises.

BACKGROUND

- 5. An application for a public entertainment licence was determined at the Licensing and Safety Committee held on 10 September 2003. At that meeting, neighbouring residents objected to the issue of a licence. However, after careful consideration, Members decided to grant the public entertainment licence for a period of 6-months.
- 6. The public entertainment licence was issued on 12 August 2004 as it was some considerable time before the work required by the Council was completed.

CURRENT POSITION

7. The applicant has applied to renew the public entertainment licence. The hours are as previous:

Wednesdays 11.00am until 11.00pm Saturdays 11.00am until 11.00pm

REPRESENTATIONS

- 9. Lancashire Police have no objections to the renewal of this licence.
- 10. Environmental Services Unit do not wish to object, but have made the following recommendations:

The self-closer on the internal door leading from the main bar area towards the rear external door does not seem to work properly and the door jams open on the carpet. This will result in the escape of noise from entertainment in the bar area. The closer should be replaced or repaired and the door adjusted so that it does not stick in the open position. The self-closer on the external door to the decking is not effective which will result in escape of noise from entertainment. The closer should be replaced or repaired and the door adjusted so that it does not stick in the open positions. The use of the decking area during entertainment will result in additional noise from patrons and escape of noise from the entertainment in the bar area when they move in and out of the premises. The closure of the decking when the entertainment is taking place would reduce this. Internal from door glazing panel has not yet been fitted with double or secondary acoustic glazing to a specification agreed with the Council.

- 11. Planning have no comments to make on this application.
- 12. Two objections have been received from neighbouring residents which are attached to this report. Both objectors have been invited to attend today's committee.
