LEISURE CENTRE FEES & CHARGES 2018/19

PURPOSE OF REPORT

1. To consider recommendations made by Active Nation for fees and charges for 2018/19 and approve the fees and charges.

RECOMMENDATION(S)

2. To approve the fees and charges, as proposed by Active Nation, with effect from 1 April 2018.

EXECUTIVE SUMMARY OF REPORT

- 3. As part of the Council's Indoor Leisure Contract, Active Nation are required to make recommendations for fees and charges for the coming financial year. Any additional income is retained by Active Nation.
- 4. The average increase proposed by Active Nation is 4%

5. To approve the increase in fees and charges for the period 1 April 2018 to 31 March 2019.

- 6. If the recommended fees and charges were excessive, the council could refuse them. The proposed fees and charges are viewed as appropriate.
- 7. To increase fees and charges significantly more than recommended. Active Nation are of the opinion this would reduce attendances and impact on income.

BACKGROUND

- 9. Under the terms of the Contract, Active Nation are allowed to increase fees and charges for use of the facilities as long as they are in line with inflation and rounded up to allow for efficient cash collection. They are, however obliged to inform the council and obtain approval that they are compliant. Any additional income from these approved changes is retained by Active Nation.
- 10. In making their recommendations, Active Nation analyse existing usage at the centres, fees and charges made by other providers and the required outcome to increase usage. For example David Lloyd who provide a health and fitness facility in Chorley charge from £70 per month for a comparable adult membership. South Ribble Council whose facilities are operated by SERCO charge £37 per month for adult membership. Active Nation promotes reduced price membership packages and offers periodically through the year.
- 11. Active Nation are taking on average 240 Time Credits per month, equating to 240 hours of swimming, gym use or class activity at nil cost for Chorley residents who contribute their time as a volunteer in the community.
- 12. The November 2017 RPIX value was 2.5%. The average percentage price increase is 2.65%; charges have been rounded to allow for efficient cash collection. There is no increase in monthly direct debit fitness subscriptions at Clayton Green.
- 13. The table below shows the most popular activities at Active Nation facilities in Chorley and the proposed changes.

14. Currently Active Nation have over 100 different prices for various group exercise classes. A number have been in place for many years and with low attendances a high number are now unsustainable. In order to ensure we can be more cost effective and supply the largest timetable of activities, Active Nation have decided to introduce four different group exercise prices. A 30-minute class will be £3, A 45 minute to 1 hour class will be £5 and a 90 minute class will be £7.00. The only variation is any Les Mills class will be £5.50 due to the additional licence cost. These costs are fully in line with industry and competition.

15. It is important the fees and charges are set at a reasonable level to encourage usage of the Leisure Centres. This then helps to increase physical activity levels, support people in living healthy lifestyles, provide affordable family activities and offer positive diversionary activities for children and young people. All of these factors contribute to the Council's Corporate Strategy vision, priorities and outcomes.
