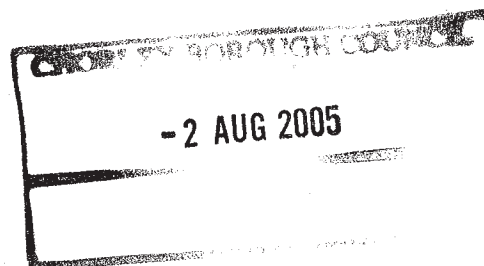



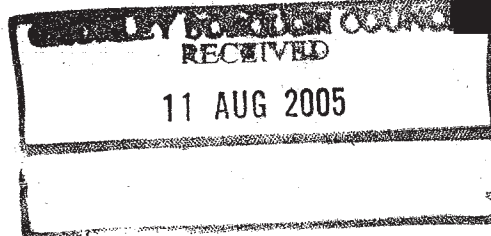

We have read with some concern the planning application by Hartwood Hall Hotel for extended opening hours every day of the week until 2.00am.

We have lived in this house, which is directly across the road from the hotel, for 28 years now and we remember vividly the problems caused when the previous owners of Hartwood had a late licence at weekends. On a regular basis we had groups of youths coming out of the hotel late at night shouting, laughing and causing damage to both public and private property. The bus shelter regularly had its glass panels kicked in and there were bottles, cans and glasses smashed on the pavement and litter everywhere.

Your figures show that the crime rate goes up with extended drinking hours so we wish to register our objection to this plan in the strongest possible terms on the grounds of public nuisance.

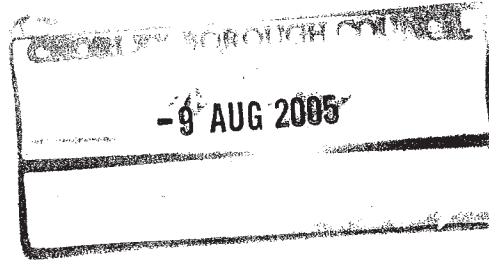

The premises will respect Spirit Group's Approach to Responsible Drinking (a copy of which is enclosed in support of this application). Our policies change at regular intervals to reflect current trends and it would be inappropriate to standardise them on a permanent basis. 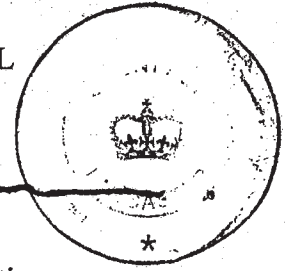

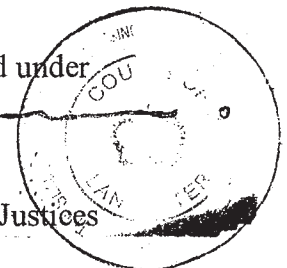

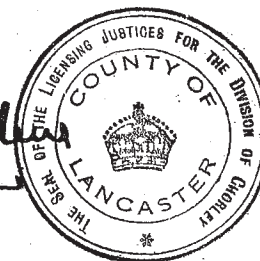
