MANDATORY DRINKS CODE

No supply of alcohol may be made under the premises licence - (a) at a time when there is no designated premises supervisor in respect of the premises licence; or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

ALCOHOL PROMOTIONS

(1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to

the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective ;

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;

(d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner

DISPENSING ALCOHOL

(e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

FREE TAP WATER

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

AGE VERIFICATION

(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either?

(a) a holographic mark, or .

(b) an ultraviolet feature. .

ALCOHOL MEASURES

The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) beer or cider: 1/2 pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

I am PC 6884 Stephen Connolly of Lancashire Constabulary, currently attached to the South Licensing Team based at Preston Police Station.

I make this statement in relation to an application submitted to Chorley Borough Council to review the Premises Licence PLA0155 which relates to TONY'S OFF LICENCE, 50 BOLTON ROAD, CHORLEY.

I submitted this application on behalf of Lancashire Constabulary due to concerns over the premises upholding the Licensing Objectives of Crime & Disorder and Protection of Children from Harm.

The person relevant to this premises is Vekaria BHARAT, who is the Designated Premises Supervisor (DPS) and the Premises Licence Holder. BHARAT holds a personal licence issued by GREENWICH COUNCIL and has been the DPS at TONY'S OFF LICENCE since 15th August 2018.

On Wednesday 28th April 2021 at approximately 18:55hrs the premises was subject to an alcohol test purchase operation by PC 2388 Stewart. PC Stewart arranged for a 15-year-old test purchaser to attend the premises and buy a bottle of rosé wine, the cashier initially refused the sale before asking the test purchaser to remove their face mask and saying "OK, I'LL LET YOU OFF THIS TIME" before allowing the sale to go ahead. PC Stewart spoke with the cashier following this who alleged that they had only worked at the premises for two weeks, had not been given any training, had no knowledge of the refusals register, training records, CCTV, or authority to sell. PC Stewart spoke with BHARAT on the telephone and claimed that the cashier was lying, and the training records were at his home, PC Stewart went on to say that BHARAT advised the CCTV was fully working despite the screen in store being blank. PC Stewart also noted that the premises had out-of-date refusals register and was unable to find any written authority to sell alcohol.

On Monday 5th September 2022 at 20:27hrs, Lancashire Constabulary received a 999 call from a member of the public stating that they were inside the premises and had assaulted the staff member on duty as earlier that evening her 16-year-old son had attended and had bought Nitrous Oxide from the staff member. PC 673 Newton and PC 4938 Cutts attended this report and upon arrival activated their bodyworn cameras and began speaking with a female that advised that she had rang 999 after discovering that her 16-year-old son had been sold "BALLOONS" at the premises earlier that evening.

"BALLOONS" is a slang term for Nitrous Oxide, a substance which is deemed psychoactive by the Psychoactive Substance Act 2016 and as such the sale for human consumption is a criminal offence. Nitrous Oxide is a gas & balloons are inflated with it to allow its user an easy way to inhale the gas. Nitrous Oxide is a dangerous substance that can cause significant health issues for those that inhale it & on occasion has caused suffocation resulting in death.

Officers speak with the cashier & the complainant separately. The cashier stated that she had been assaulted by the complainant but wasn't bothered about that. When asked by PC Newton what had happened, she made comments along the lines of "THE GUY WHO CAME IN LOOKED OLD ENOUGH, I'M JUST DOING MY JOB" when asked what the cashier had sold, she replied "SMARTWHIP" and PC Newton asked the cashier to clarify what that was to which the cashier replied "BALLOON THING". PC Newton asked if the shop regularly sold the Smartwhip to which the cashier paused before saying "WE'VE GOT WHAT WE'VE GOT IN THE BACK" before saying "I FEEL LIKE A PIECE OF SHIT AS I DON'T LIKE SELLING THEM". PC Newton asked why the cashier felt this way to which they replied, "FOR OBVIOUS REASONS, YOU SEE IT ALL THE TIME ON FACEBOOK, PEOPLE DYING OFF IT". The cashier then stated that "HIS MATE (in reference to the complainant's son outside) HAS COME IN, RECOGNIZED ME AS HE DELIVERS FOOD TO MY HOUSE. AS HE DRIVES, HE'S OLD ENOUGH, SOLD IT HIM."

A short time later PC Newton asked the cashier to clarify what had happened where they advised they had sold "SMARTWHIP" and that they "DIDN'T EVEN SEE HIM (in reference to the complainant's son outside), THERE WAS A RED CAR PARKED OPPOSITE. THE GUY CAME IN WE HAD A LITTLE BANTER, SOLD IT AND THAT WAS IT" followed by "AND I'M PRETTY SURE HE (in reference to the complainant's son outside) CAME IN AND ASKED HOW MUCH IT WAS, NOT SURE IF HE BOUGHT AN ECIG OR MAYBE GOT A DRINK".

Following this PC Cutts was led to the rear storeroom by the cashier and was shown the two boxes containing the remaining 7 cannisters was located; the boxes were located on the floor of the stock room behind & underneath other boxes of alcohol, the location would suggest that attempts were made to conceal them within the premises. PC Cutts seized 7 large cannisters of Nitrous Oxide at this point.

Lancashire Constabulary recorded this incident under LC-20220905-1422 with the following criminal investigations common assault, threats to destroy or damage property and possess a psychoactive substance with intent to supply.

On Sunday 9th September 2022, Lancashire Constabulary received a report from the cashier regarding the assault, the report was submitted online and included a recording of the CCTV screen showing the assault. Neither BHARAT nor any other representative of TONY'S OFF LICENCE provided Lancashire Constabulary with footage of the sale of Nitrous Oxide on the evening of 5th September. It was only some time after applying for the licence review was, I made aware of this footage being sent in by the cashier.

On Thursday 15th September 2022 I attended the premises in company with Lancashire Trading Standards and a Licensing Officer from Chorley Borough Council where we undertook an inspection of the premises licence and discussed the incident with BHARAT.

Noted during my inspection was a 'slushed ice' machine by the counter which was currently switched off. attached to the side of the machine was a handwritten notice advertising "adult slushies" made with a double measure of vodka or gin. I questioned BHARAT about this, specifically his process around measuring out the alcohol and he advised that he used to have a plastic cup which he measured out two shot glasses of alcohol, poured them into a plastic cup and drew a line on it with marker pen to determine the measure when serving the "adult slushies". I advised him that this was not a correct means of measuring out the alcohol. BHARAT said that it was not a popular drink anyways and removed the signage from the machine.

I also discussed the sale of the Nitrous Oxide with BHARAT, who presented me with a typed policy that the store had for the sale of it, which consisted of a few bullet points around the sale & risks of inhaling Nitrous Oxide - the policy appeared to have been printed recently. BHARAT advised that staff were trained ref selling Nitrous Oxide but was unable to provide anything regarding what staff were trained, by who and when the training took place. BHARAT claimed that he had been selling them recently to takeaways, when asked where he purchased them, he initially stated "AMAZON" but then denied having an account, he then claimed that someone had bought them for him before changing to buying them from a catering supplier. BHARAT was unable to provide anything more specific.

I also noted that the premises had very poor age-related sales materials on display at the premises, I advised to BHARAT that he may wish to improve on this.

Finally, we reviewed the CCTV system installed at the premises and discovered that it only records for 5 days and was not able to review the footage of the incident.

During this visit Lancashire Trading Standards seized a large quantity of non-compliant e-cigarette devices.

The sale of a psychoactive substance for human consumption is a serious matter and is a criminal offence under the Psychoactive Substances act 2016 due to the risk to public health they can pose. Data from the Office for National Statistics states that between 2001-2020 there have been 716 deaths related to volatile substances registered across England & Wales, of this data Nitrous Oxide was mentioned 56 times on death certificates making it the 3rd most common volatile substance mention on a death certificate. On the same data it shows that the Northwest had the highest number of deaths involving volatile substances.

[REDACTED] INFORMED ME THAT SHE HAD ONLY STARTED AT THE SHOP 2 WEEKS EARLIER AND THAT SHE HAD NOT HAD ANY TRAINING AND DID NOT HOLD A PERSONAL LICENCE. SHE DID NOT HAVE A CLUE ABOUT TRAINING RECORDS, REFUSAL REGISTER, CCTV OR AUTHORITY TO SELL.
I THEN SPOKE TO THE DPS BHARART VERKARIA ON [REDACTED] WHO STATED THAT SHE HAD BEEN TRAINED AND THAT HER TRAINING RECORDS WERE AT HIS HOME ADDRESS. HE STATED THAT THERE WAS A TRAINING FILE BUT WHEN I LOOKED IT WAS AN OUT OF DATE REFUSALS LOG. THE CCTV MONITOR IN THE SHOP WAS NOT DISPLAYING ANY IMAGES BUT HE TOLD ME THAT IT WAS FULLY WORKING AND THAT HE COULD VIEW IT FROM HOME. HE STATED THAT THERE WAS AUTH TO SELL IN THE TRAINING FILE BUT DESPITE SCOURING ALL PAPERWORK THIS COULD NOT BE FOUND. I DO NOT BELIEVE THAT THERE WAS ANY AND ADVISED HIM THAT THIS AUTH NEEDED TO BE GICVEN IN HIS ABSENCE.
I TOLD HIM THAT I WOULD SPEAK TO HIM AT A LATER DATE.
