The Parish Council has a proposed route that would keep the race entirely out of the Chorley district given that it is Bolton's Ironman UK race.

Philippa Lane (Planning Policy and Housing Officer) delivered a presentation which sought to brief members on the background of the neighbourhood plan's, how they are created and the limitations of the plan.

Councillor Kim Snape explained that she had spoken to a couple of Parish Council's over the previous months and was wondering how Parishes had found moving back to face to face meetings.

17.12 Item requested by Wheelton Parish Council

A question was submitted in relation to refuse contracts and 20 mph zones in Chorley.

17.13 Item requested by Croston Parish Council

A report and question were submitted in relation to Knotweed.

The answer was provided in advance of the meeting and acknowledged.

17.14 Questions from Members of the Liaison and the public

Graham Ashworth (Heath Charnock) asked if it was possible to separate Heath Charnock from Chorley South East when sending out the weekly planning list. Officers agreed to investigate this further and provide an update outside of the meeting.

Councillor June Molyneaux advised that an item had been discussed at Adlington Parish Council regarding electric vehicle charging points and asked if the Climate Change Working Group could look at this further. In response, Councillor Clifford agreed to mention the topic at the next meeting of the working group.

17.15 Items for Future Meetings

The Chair confirmed the items for future meetings and asked for recommendations for future agenda items.

It was agreed that electric charging points, information on charging infrastructure for those in terraced houses and a general discussion on the special expenses charge on council tax being tied to council tax precepts would be included as a future agenda item.

Karen Wait (Bretherton Parish Council) asked for guidance on how to proceed with obtaining signage for the village warning drivers about potential horse riders on the road. In response County Councillor's Snape and Riggott advised that the Parish

Alternative Ironman Route

- 1. When entering Belmont Village by Edgerton Road, turn left onto the A675 Belmont Road for approximately 1 mile
- 2. Take a right onto Scout Road until you reach the junction with the B6226 Chorley Old Road at the Bobsmithy Public House
- 3. Turn right to Horwich and through to Lee La, at the junction of the A673 and the Crown Hotel, take a full left turn (approximately 160 degrees onto Chorley New Road)

This would then take you back onto the Ironman Route keeping the event out of Lancashire as previously agreed.
